For his part, Carlos Ballesteros said, "from ANESE, we believe that this agreement with EVO marks a clear commitment by the association to the training and professionalization of the energy efficiency sector in Spain. In the context of growth driven by the Energy Saving Certificates (CAE) system, it is crucial to provide professionals with the necessary qualifications to face the challenges of the market.





This collaboration will reinforce knowledge and rigour in implementing measurement and verification protocols, providing key technical tools to verifiers, regional managers, obligated and delegated subjects, and other system agents. In turn, it will facilitate the accreditation of unique actions within the CAE system, establishing uniform criteria for implementing the IPMVP protocol among the different actors.

We are convinced that through collaboration we will be able to promote the incorporation of qualified professionals into the sector, guaranteeing a level of competence and specialization in line with international standards".
